#### **1. Call to Order**

- Meeting called to order at **12:34 PM**.
- **No quorum** at the start—needed two additional students.
- President Schrader was absent; **Cochair Hector** delivered her remarks.

## 2. Approval of Minutes

- Approval of minutes for **October 28, 2025** and **November 25, 2025** postponed until quorum was reached.
- Quorum achieved at **12:52 PM**.
  - **October Minutes:** 85% approve, 3% oppose, 13% abstain.
  - **November 25 Minutes:** 80% approve, 0% oppose, 20% abstain.
- Note: Minutes were distributed at the last minute.

## 3. Student Caucus Report (Pollack)

- Invitation to contribute to Hurricane Relief event at John Jay.
- Recognition of **SGA students** for service efforts.
- Commendation of faculty participation in SGA activities.
- Invitation to **Winter Wonderland Party** on December 11 in the Atrium.

## 4. President's Report (Delivered by Hector)

- Gratitude to all who participated in **Giving Tuesday**.
  - **247 donors** contributed **\$114,320** as of midnight on CUNY Tuesday.
  - CSI raised over **\$200,000**; competitive “game day” challenge increased visibility and donations.
  - Raised **\$17,450 more** than last year.
  - Donors increased from **128 to 247**.
  - Donations remain open until **December 31**.
- Thanks to all who donated food items in November.
- Appreciation to student government and department chairs for scheduling academic department meetings—an early step toward coordinated campus-wide calendar planning.
- **Financial Recovery Plan Updates:**
  - Hiring pause remains, with limited exceptions.
  - Search committee forming for Grants Officer.
  - Planning for Annual Elected Officials’ Breakfast is underway.
  - Delegation trip to Albany planned.
- **Enrollment & Retention:**
  - Progress noted but challenges remain.
  - V-Ready initiative continues to help.
  - Faculty encouraged to assist with January enrollment.
  - Enrollment increased from **2,154 on 11/25** to **2,500**, with a target of **4,161**.
  - Slightly ahead of last year’s numbers.

- VP Rivera distributes weekly enrollment reports; members encouraged to review.
- **Continuing Education (CE) Survey:** 53% of respondents interested in teaching in York NOW.
- Reminder to support students experiencing distress during finals.
- Congratulations to several alumni for recent achievements.
- November updates to be shared this week; year-end report coming this month.

- Curriculum report could not be discussed—committee had not received it in advance.
- VP Hoeffner visited to emphasize the importance of surveys and committee structures.
- Ongoing concerns regarding room reservations: faculty unhappy with **30-day advance** requirement; Sandra Velez will attend February meeting to discuss.
- SAP (Satisfactory Academic Progress) process reviewed.
- Zoom processes continue to work well for meetings.

  - Improve emergency response.

- Our regional hub will be located at **Queensborough Community College (QCC)**.
- **Archibus system** will handle all work requests.
- Roof repairs remain the most common (and outsourced) work orders.
- Many York requests not submitted through Archibus—leading to inaccurate data. Training recommended.
- Staff will **remain on campus**, though some may transfer to the hub; workflow will be centrally managed.
- Combined hub staffing expected to improve service capacity.
- Key campus responsibilities:
  - Preparing office space.
  - Updating work requestor lists.
  - Communicating with service providers.
- Launch expected **first half of 2026**.
- **Town Hall scheduled Friday at 10 AM via Zoom**; Veronica will distribute link.

2. Approval of Minutes for Tuesday, December 9, 2026 (Vote): Votes could not be held because the meeting took place virtually in Zoom
3. Faculty Caucus Leader (Sheidlower) reported on last Faculty Caucus meeting
4. Student Caucus Report (Ibeh)
  - Dates for Town Halls were provided
  - Happy holidays: Ramadan, Black History month
5. President's Report (Schrader)
  - a. Enrollment & Hiring
    - Hiring freeze implemented due to the college's high-concern status; searches for interim positions have begun.

- Enrollment has increased by 5.6%, marking the largest increase among senior colleges after CCNY.
  - Noted significant decline in freshman enrollment, with increases across all other student categories.
  - Ongoing concern: heavy concentration of high school students makes up approximately one-third of total enrollment.
    - Discussion: Need to improve mechanisms to convert high-school enrollees into matriculated, degree-seeking students.
- b. Advisement & Student Support
- VP Rivera is engaging departments about closer collaboration on advisement.
  - York Opportunity Scholarships will continue.
  - V READY continues active student support.
  - Fall registration begins March 2, starting with priority groups.
  - Retention emphasized as equally important as enrollment; potential policies may be contributing to attrition and should be reviewed.
- c. Communications, Marketing & Technology
- Upcoming improvements to student-facing IT and Communications/Marketing webpages planned.
- d. Partnerships & External Engagement
- VP Rivera is running a partnership program with community colleges, meeting 1–2 times per month.
  - Workforce Development / Continuing Education (CE) program development is underway.
  - The college aims to participate in the second wave of the CUNY Beyond program.
  - Lobbying continues for the creation of an Academic Village, including a “library of the future.”
  - Request made to Senator Comrie to consider adding York to the Jamaica Station name.
- e. Events & Government Relations
- Governor Hochul visited the campus childcare program.
  - York hosted the annual legislative breakfast in January, with strong attendance.
  - Participation in:
    - Queens Legislative Breakfast (January)
    - Black/Hispanic Legislative Caucus (February)
    - Panel at resort industry event to expand career opportunities
  - Students have been strong advocates at various public events.
  - President recently testified at the Borough President’s office requesting \$2M, including funding for a presidential lecture series.
- f. Fundraising & Scholarships
- Fundraising progressing strongly:
    - \$115K raised on Giving Tuesday
    - \$270K total raised
    - 120 first-time donors
  - Scholarship website has been updated.

      - Auxiliary Enterprises preparing to leverage potential discretionary funds.
      - PAC staffing plan under Sandra Velez; seating capacity has increased.

- 1) Are the changes to this minor the result of departmental assessment and/or an APR (Academic Program Review)? If no, skip to question 4. If yes, please describe:

Yes. Few, if any, students had completed the minor since its introduction; the department curriculum committee met to review possible reasons. We determined that a number of the elective courses from categories II and III in the original minor were not regularly offered, including BLST 323, CT 390, and MUS/FA 278. We decided to add EDUC 286, JOUR 388, and FA 284 and 384, all of which have been offered recently, and all of which fit into the minor's intent. To add more flexibility for students interested in the minor, a choice of two foundation courses has been added, and categories II and III have been condensed into a larger 'minor electives' category, increasing the likelihood that students will be able to find courses on offer that allow the minor to be completed.

- 2) Which program-level student learning outcomes (PSLOs) are met by this minor change? Please copy and paste the relevant PSLOs and explain how the revised minor meets them (e.g. connect to major assignments, course activities, and/or themes).

*PSLO 1. Students will explain, analyze, and apply the terms, theories, frameworks, and contexts of the relevant discipline (linguistics, literature, or writing).*

The minor's required foundation courses (ENG 295 or 297) accomplish this goal by introducing terms, theories, frameworks, and contexts relevant to literature and writing (ENG 295) or linguistics and writing (297) through the lens of digital studies. These goals are further reinforced in the student's chosen digital minor electives.

*PSLO 3. Students will write well-structured, articulate works in discipline-appropriate genres, including but not limited to academic, professional, creative, and public writing.*

The minor's required foundation courses (ENG 295 or 297) are both permanently Writing Intensive courses, which reinforce skills developed in introductory composition by providing writing practice in the relevant discipline.

*PSLO 4. Students will gather and critically evaluate information, use information that they retrieve to accomplish a specific purpose, and incorporate retrieved information responsibly and ethically.*

Information literacy is a key component of digital studies; information literacy skills are developed throughout the minor, from the foundation courses to the electives.

3) How will this revised minor be assessed in the future?

The minor will be assessed with the other minors offered in the English program (English and Creative Writing) as part of the upcoming English APR.

# RESOLUTION

York College Senate

Dear Senators:

The Committee on Academic Policy and Standards, pursuant to your delegation under the York College Charter “to review and recommend policies relating to the academic policy and standards of the college,” will propose the following revision to the College policy:

*For grades of incomplete (INC), assigned by the instructor in consultation with the student when there is a reasonable expectation that the student can successfully complete the requirements of the course, no later than the last day of classes of the following semester.*

## Summary of current policy:

We quote the York College Undergraduate 2023-2024 Bulletin for the policy which seems to have changed and/or been altered in the following 2024-2025 bulletin but not yet documented as voted upon and adopted by the Senate. The verbiage is as follows:

2023-2024:

*The INC grade is assigned at the discretion of the instructor. The student has up to 10 weeks in the subsequent semester to complete the work and have the grade resolved even if a student is not registered in the subsequent semester.*

2024-2025

*For grades of incomplete (INC), assigned by the instructor in consultation with the student when there is a reasonable expectation that the student can successfully complete the requirements of the course, no later than the last day of classes of the following semester.*

## Reason to modify current policy:

The philosophy of the current resolution is to provide York and its students with the opportunities for academic success and student achievement while keeping aligned with CUNY’s policies and best practices.

The policy found in the 2024-2025 bulletin as being proposed, has been in practice since 2024-2025 and, moreover, was a practice done during COVID-19 in 2021 to give students ample opportunity to rectify their incomplete grades. This was done rather than only allotting for 10 weeks into the subsequent semester, as previously practiced, to ensure greatest academic success.

However, even if this practice may appear in the 2024-2025 bulletin, it has come to the attention of the Committee on Academic Policy and Standards that solidification in making this practice a college wide policy has not been voted on by the Senate.

**Proposed Resolution:**

For the foregoing reasons, we propose the following modification to the York College academic policy:

*Resolved: Effective for the 2026-2027 Academic Year, for grades of incomplete (INC), assigned by the instructor in consultation with the student when there is a reasonable expectation that the student can successfully complete the requirements of the course, no later than the last day of classes of the following semester.*

## RESOLUTION

York College Senate

Dear Senators:

The Committee on Academic Policy and Standards, pursuant to your delegation under the York College Charter “to review and recommend policies relating to the academic policy and standards of the college,” will propose the following revision to the College policy:

*All matriculated students (this excludes non-degree students), who at the end of the Spring or Fall semester do not meet the retention standard of 2.0 or above (based upon their cumulative GPA) will be placed on probation at the end of the term. Matriculated students who are placed on probation will be notified by the Office of the Registrar of probationary status.*

*If the matriculated student who is placed on probation does not achieve the required term GPA of 2.01 by the end of the following Spring semester and cumulative GPA remains below a 2.00 at the end of that Spring semester, then the matriculated student will be dismissed from the college. Matriculated student who are dismissed from the college will be notified by the Office of the Registrar of dismissal status.*

### **Summary of current policy:**

We quote the York College Undergraduate 2023-2024 Bulletin for the current policy:

*All students, regardless if they are matriculate or non-matriculate, who at the end of the Spring or Fall semester do not meet the retention standards of 2.0 or above (based on their cumulative GPA will be placed on probation at the end of the semester.*

*If a student is placed on probation they will be notified in writing by the Office of the Registrar and the Committee on Academic Policy and Standards (CAPS).*

*The academic probation status remains on a student's record for the entire semester(s) until the student reaches the cumulative GPA of 2.00 or better. In addition, the student must achieve a term GPA of 2.01 each semester. If the student does not achieve a term GPA of 2.01 and the cumulative GPA is below 2.00 at the end of the Spring semester, the*

*student will be dismissed. If not achieved by the following Spring semester the student is dismissed.*

*Once a student is placed on probation and the student does not achieve the required term GPA of 2.01 by the end of the following Spring semester, the Office of the Registrar and Committee on Academic Policy and Standards (CAPS) will notify the student in writing that they have been dismissed for academic reasons after failing to meet the minimum retention standard while on probation.*

**Reason to modify current policy:**

The philosophy of the current resolution is to provide York and its students with the opportunities for academic success and student achievement while keeping its best practices aligned with other CUNY colleges; Lehman, Baruch, Medgar Evers, City Tech, Queens College.

Our CUNY sister colleges keep with the best practice with placing only their matriculated students on probation or dismissing them from the college. Their non-matriculated students do not face academic probation or dismissal for failure to maintain a cumulative GPA of 2.0 or higher.

Additionally, the Committee on Academic Policy and Standards member questioned the current practice of placing non-matriculated students on academic probation or dismissing them from the college because those students do not have full access to the broad array of support services available to our matriculated students.

**Proposed Resolution:**

For the foregoing reasons, we propose the following modification to the York College academic policy:

*Resolved: Effective for the 2026-2027 Academic Year, all matriculated students (this excludes non-degree students), who at the end of the Spring or Fall semester do not meet the retention standard of 2.0 or above (based upon their cumulative GPA) will be placed on probation at the end of the term. If a matriculated student is placed on probation, they will be notified by the Office of the Registrar of probationary status.*

*If the matriculated student who is placed on probation does not achieve the required term GPA of 2.01 by the end of the following Spring semester and cumulative GPA remains below a 2.00 at the end of that Spring semester, then the matriculated student will be dismissed from the college. If a matriculated student is dismissed from the college, they will be notified by the Office of the Registrar of dismissal status.*

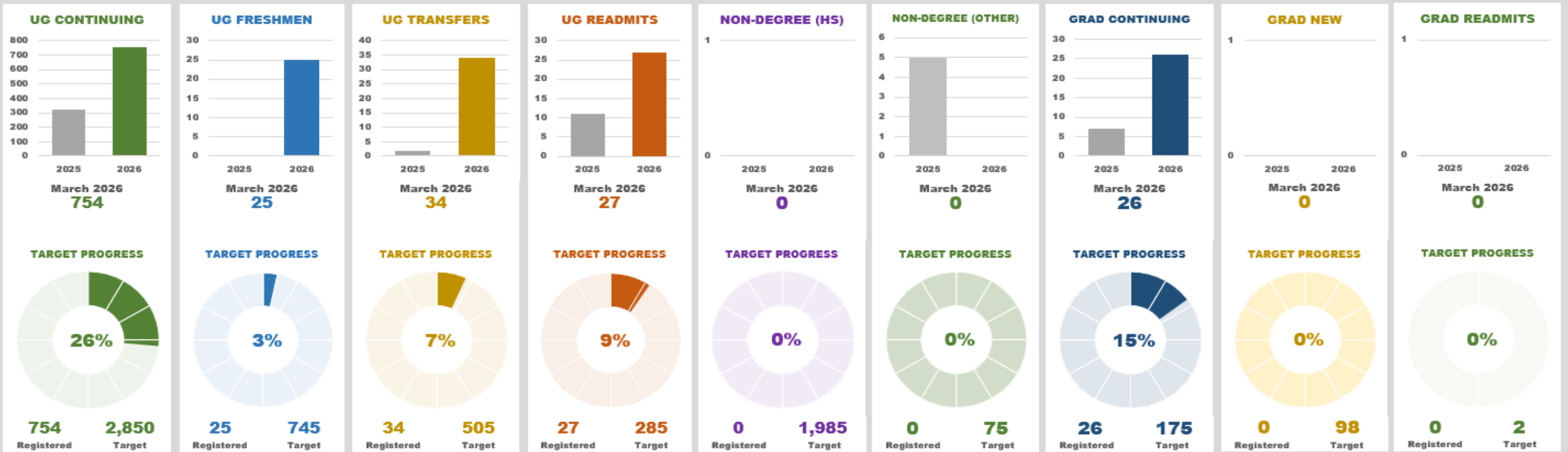

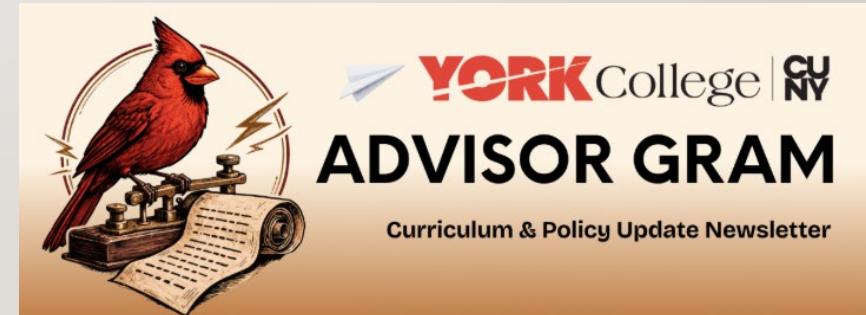

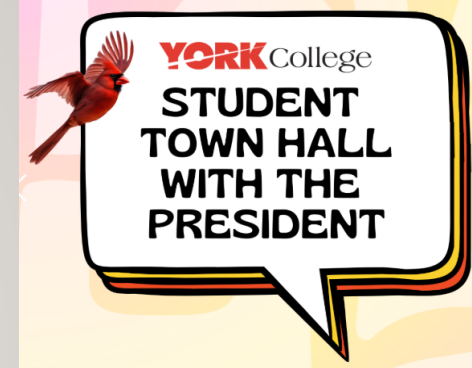
